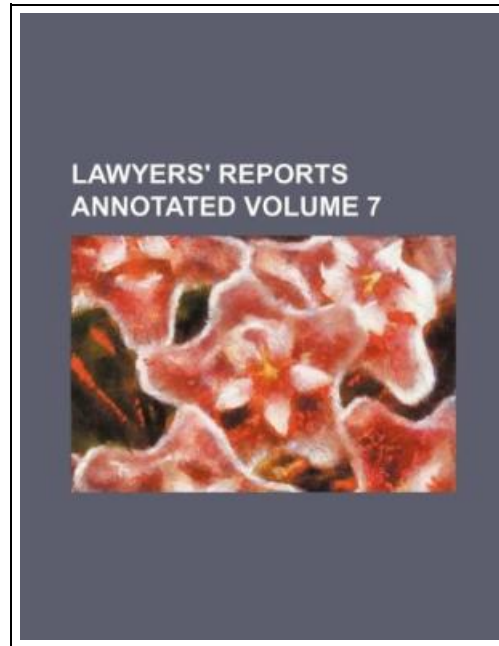

The first and general rule relating to warranty in contracts of sale is that the buyer purchases at his own risk--careat emptor--unless the seller either gives an express warranty, or unless a warranty is implied by law, or unless the seller is guilty of a fraudulent representation or concealmeut (Story, Sales. 401): but the rule caveat emptor never applies to cases of fraud.
