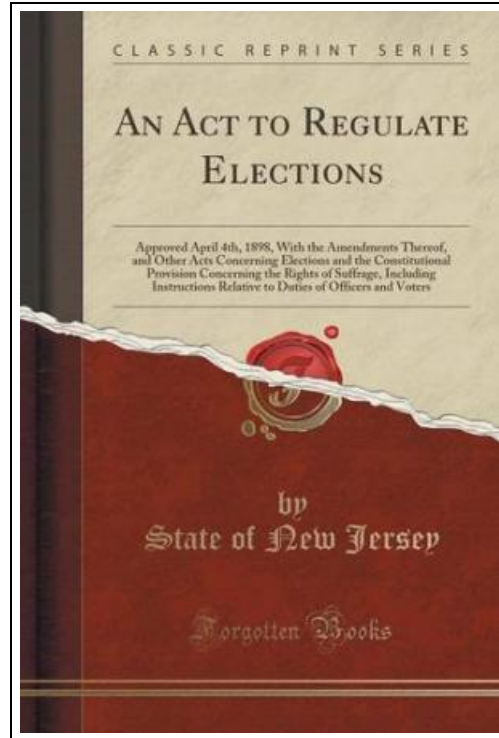

Section 486. (This section applies to candidates at primary election.) Candidates to be voted for at primary election are required to render an accounting from the above-mentioned date to the time for the holding of primary election, namely, September 24th, 1918. March 5th, 1918 - Any person who becomes a candidate for nomination for or election to any public office, without having publicly announced his candidacy more than eight months prior to the general election, shall be conclusively presumed to have been a candidate for a period of eight months next preceding the holding of the general election at which the candidate is to be voted for. Section 486. (This section does not apply to candidates who are to be voted for at primary election.) Candidates to be voted for at the general election are required to render an accounting from the above-mentioned date to the time for the holding of the general election, namely, November 5th, 1918. April 20th, 1918 - It shall not be lawful for any governing board or body of any...
